**Sub:** Notice Regarding Registration for Students in Intermediate Years of B.Tech Programmes for Even Semester (2025-26 Academic Session).

The students of IIIT Agartala, are hereby informed to pay their semester fee indicated in Table-1 in the following bank account, starting from 30-12-2025 :

To make them eligible for subject registration during Even Semester (2025-26).

1. All the students, are hereby instructed to mandatorily upload/update their payment/bank details through **Google Form: <https://forms.gle/rKneYUNhYdDgyUxi8>** and also instructed to keep a payment receipt copy for future reference.
2. The students will be allowed for subject registration through online portal after paying the semester registration fees from 30-12-2025 as indicated above.
3. Students, after completing the formality indicated above, will have to register the subjects provisionally through the same online portal (**Academic → Registration → Semester Registration**). All core subjects will be pre-selected by default. Student has to click on submit button to complete their provisional registration and retain the provisional registration slip.
4. After completion of above steps, students need to **mandatorily report physically** to their Faculty Advisor and/ or UG Coordinator (as applicable) of respective Department. The Faculty Advisor and/ or UG Coordinator will then verify the fee payment/ subject registration on their MIS portal and to complete the semester registration process for the student.
5. Physical Reporting (Sl. no.- 4) to be completed by the students at Institute till 09/01/2026. Beyond this date, fine will be applicable as per Institute Rule.
6. All bank loan holder should adhere to these dates. Beyond this date, fine will be applicable as per mentioned below:
  - a. Late physical registration fee up to 7<sup>th</sup> working days from the last date: ₹1,000.00
  - b. Late physical registration fee from the 8<sup>th</sup> working day to the 14<sup>th</sup> working day: ₹5,000.00
  - c. Physical registration beyond 14<sup>th</sup> working days is not permitted.
7. Classes will be commencing on 07/01/2026 and a student should have to attain at least 75% attendance to appear Mid-Term and End-Term Examination in any subjects/ labs w.e.f 07-01-2026. Else, student(s) will be debarred in that subject(s).
