- 1. All the students, are hereby instructed to mandatorily upload/update their payment/bank details through **Google Form:** https://forms.gle/ehxj1q1aEiDomN7P6.
- 2. Students, after completing the formality indicated in Sl. No. 1, will be allowed to register the subjects provisionally through the same online portal (Academic→ Registration→ Semester Registration). All required subjects are to be selected by each student before clicking on submit button to complete their provisional registration and print 3 (three) sets of provisional registration slip. All three registration slips are to be signed physically by the respective students and concerned faculty advisor/supervisors of the students and to be submitted to UG co-ordinator of the respective Departments. One signed copy of the registration slip is to be handed over to concerned student later on.
- 3. The fees for the program & semester are mentioned in Table 1, are applicable from **06/01/2024** to **15/01/2024**. Beyond this period fine will be applicable as per Institute Rule.
- 4. Regarding hostel related matters, students may contact the Office of the Chief Warden.
- 5. As per Academic calendar circulated, classes being commenced from 8/01/2024(Monday) and a student should have at least 75% attendance to appear Mid-Term and End-Term Examination in any subjects/labs.
